Terms and Conditions of Using Internet-Based Payment Services

It is your responsibility to keep your PayPal Account and PayPal Funding Source current and funded, and your PayPal Account backed by at least one valid credit card. You agree that PayPal and the APSC will not be responsible for payments that fail to go through as a result of your PayPal Account or PayPal Funding Source no longer existing or holding insufficient funds. If for any reason PayPal is unable to withdraw the full amount owed for your purchase, you agree that PayPal and the APSC may pursue all available remedies in order to obtain payment. You agree that if the transaction is returned unpaid, you will pay a service charge of US\$25.00 or the maximum amount allowed by law, which may be debited from your PayPal Account or PayPal Funding Source.

By clicking the "Buy Now" button, you agree to the terms of the PayPal payment option, you authorize a debit of the full amount of your APSC Fellowship from your PayPal Account or PayPal Funding Source.

postal address listed on your APSC Fellowship application, or by posting notices of general information on the APSC Website.

3. Governing Law. The laws of Japan govern all Terms and Conditions of Use of the APSC Website and all Terms and Conditions of the Use of Internet-based payment services, such as PayPal. You expressly agree that exclusive jurisdiction for any claim or dispute with the APSC resides in the Kyoto District Court.
